## *Co-Occurring Conditions Training*

## About co-occurring conditions

Drug, alcohol and mental health difficulties are often co-occurring rather than separate problems to be addressed independently. People with co-occurring conditions can find it hard to engage with support, and services too often fail to meet their needs because they are not equipped to respond in an integrated way.



### Why this training matters

Dame Carol Black's independent review of drugs underlined the complex relationship between mental health and drug and alcohol use. The review identified that too often people are being excluded from mental health services until they resolve their drug problem, while also being excluded from substance use services until their mental health problems have been addressed.

#### National evidence shows that:

- **74%** of people starting drug and alcohol treatment have a mental health treatment need, demonstrating widespread co-occurring conditions. *(Source: Co-Occurring Mental Health & Substance Use Delivery Framework 2025)*
- Individuals are frequently turned away from mental health services due to substance use, and vice versa.
- This lack of integrated care contributes to higher risks of suicide, overdose, disengagement from services, and an increased demand for crisis care.

### What problem does this training solve?

The Co-Occurring Mental Health and Substance Use Delivery Framework (2025) calls for a fundamental shift in how services work together, placing responsibility on the **whole workforce**, not just specialist teams, to provide integrated, trauma-informed support.

This training directly responds to that challenge by equipping all staff with the knowledge, language and practical skills needed to... *(continued)*

- ✔ Build confidence in identifying and responding to co-occurring needs.
- ✔ Promote integrated working that is trauma-informed.
- ✔ Reduce stigma and missed opportunities for support.
- ✔ Support aims for collaborative, person-centred care across sectors.

Improving workforce knowledge and confidence directly improves the care people receive. Rather than focusing on service boundaries and diagnoses, the training strengthens a staff member's ability to work with the person in front of them. This leads to better engagement, more appropriate interventions, and improved outcomes for individuals experiencing both mental health and substance use challenges.

## About this training

This is a specialist, two-module training package that brings together:

- Drug and alcohol awareness
- Co-occurring mental health and integrated working

Together, they provide a well-rounded, practical foundation for anyone working with people who experience challenges with both their mental health and substance use.

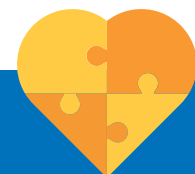
